BACKGROUND AND FINDINGS:

The Municipal General Election was held on November 7, 2017 where a ballot proposition for the imposition of the PARC Tax was submitted to the registered voters within the city and a majority of those voters voted in favor of that ballot proposition.

In accordance with Utah State Code §59-12-14, the legislative body shall by ordinance provide for the distribution on the entire amount of the revenues collected from the tax revenues collected from the tax imposed.

The PARC Tax will take effect on April 1, 2018 and remain effective for 10 years after that date.

PREVIOUS LEGISLATIVE ACTION:

2008 CARE Tax - Ordinance No. 12-09-2008B

FISCAL IMPACT:

The estimated fiscal impact will increase revenues of \$40,000 annually.

AN ORDINANCE IMPOSING A 0.1% LOCAL SALES AND USE TAX FOR THE PURPOSE OF FINANCING CULTURAL, RECREATIONAL AND BOTANICAL ORGANIZATIONS OR FACILITIES WITHIN THE CITY; AND RELATED MATTERS.

WHEREAS, Title 59, Chapter 12, Part 14 of the Utah Code (the "Act") authorizes cities in Utah to submit to the registered voters of the city the question of whether the city should impose a 0.1% Sales and Use Tax within the city for the limited purpose of funding cultural, recreational and botanical organizations or facilities in the city (the "PARC Tax"); and

WHEREAS, the Municipal General Election was held on November 7, 2017 where a ballot proposition for the imposition of the PARC Tax was submitted to the registered voters within the City and a majority of those voters voted in favor of that ballot proposition;

WHEREAS, the City shall contract, prior to the effective date of this Ordinance, with the Utah State Tax Commission to perform all functions incident to the administration or operation of this Ordinance; and

WHEREAS, the City Council has determined that a PARC Tax would be beneficial to the City and its residents through the promotion of cultural, recreational and botanical organizations or facilities in the City;

NOW, THEREFORE, be it ordained by the City Council of the City of Cedar Hills, Utah County, Utah, as follows:

SECTION 1. The City of Cedar Hills hereby imposes a 0.1% Sales and Use Tax, referred to as the "PARC Tax," pursuant to the City or Town Option Funding for Botanical, Cultural, Recreational, and Zoological Organizations or Facilities, Title 59, Chapter 12, Part 14 of the Utah Code (the "Act") for the purpose of financing cultural, recreational and botanical organizations or facilities within the City of Cedar Hills. The PARC Tax will be levied and administered under the terms of the Act.

SECTION 2. The PARC Tax will be imposed upon the transactions described in Section 59-12-103(1) of the Act, that are located within the City of Cedar Hills, except as such transactions are exempt from sales and use taxes under Section 59-12-104 of the Act. The PARC Tax shall be used to fund any eligible facilities and organizations described in the Act. The PARC Tax supplements, but does not replace, the sales and use tax established under Title 3, Chapter 2, Article A of the City Code of the City of Cedar Hills.

SECTION 3. The PARC Tax will take effect on April 1, 2018 and will remain effective for 10 years after that date. For transactions subject to the PARC Tax pursuant to Section 59-12-103(1)(b)-(m), the effective date shall be the first day of the billing

period that begins after April 1, 2018, if the billing period for the transaction begins before April 1, 2018. For catalogues sales (as defined by the Utah State Tax Commission) where the amount of the tax due is based on tax rates published in the catalogue, the effective date shall be June 1, 2018

SECTION 4. The City Recorder is directed to deliver a notice in substantially the form attached as <u>Exhibit A</u> to the Utah State Tax Commission. The City Recorder is further directed to publish a summary of this Ordinance in a newspaper of general circulation within the City.

SECTION 5. All acts, resolutions and ordinances in conflict with any part of this Ordinance are repealed and superseded by this Ordinance.

SECTION 6. The City Recorder is directed to complete the attached Record of Proceedings.

To Whom It May Concern:

This letter provides notice as required by Utah Code Section 59-12-1402(5)(b)(i)(B) that on December 5, 2017, the City Council of the City of Cedar Hills, Utah (the "City") adopted an ordinance imposing a 0.1% local sales and use tax (referred to as the "PARC Tax") within the City for the purpose of financing parks, cultural, recreational and botanical organizations or facilities within the City. The PARC Tax is imposed under the authority of Title 59, Chapter 12, Part 14 of the Utah Code. The PARC Tax will take effect on April 1, 2018, and will remain effective for ten years after that date. For transactions subject to the PARC Tax pursuant to Section 59-12-103(1)(b)-(m), the effective date shall be the first day of the billing period that begins after April 1, 2017, if the billing period for the transaction begins before April 1, 2017. For catalogues sales (as defined by the Utah State Tax Commission) where the amount of the tax due is based on tax rates published in the catalogue, the effective date shall be June 1, 2017.
