## 2011 Election Information

The City will hold a Municipal General Election on November 8, 2011, for three City Council positions (4-year terms). If needed, a Primary Election will be held on September 13, 2011. Please take note of the following information regarding elections:

**Declaration of Candidacy:** The filing period for those interested in running for a City Council position is July 1 through July 15, 2011. A candidate shall file a Declaration of Candidacy in person with the City Recorder during office hours and not later than the close of normal office hours. Candidates must be registered voters and a resident of the City for 12 consecutive months prior to the election.

**Poll Workers Needed:** If you are interested in serving as a Poll Worker during the Primary or General Elections, please contact the City at 801-785-9668, ext. 107.

**Voter Registration:** Please be sure you are registered to vote! If you have changed your name or address, even within the City, it is necessary to re-register. The County no longer has satellite registration, so you must use a mail-in voter registration form (available at the City office or on the County's Web site at <a href="https://www.vote.utah.gov">www.vote.utah.gov</a>) or register in person at the Utah County Elections Office in Provo.

# City lowers property tax rate for the 2011-12 fiscal year

The City Council voted June 22 to lower property taxes for the third time in four years. It was noted at the meeting, however, that the overall property taxes still have the potential to increase, since the City's portion only accounts for approximately 20 percent of the property tax bill, which includes taxing from the school district, county, and others.

# City's culinary water fees are below area average

Compared to other Utah County cities, the City of Cedar Hills provides its residents with a great value on culinary water. Even though we have higher than average pumping costs, due to significant differences in elevation within the City, the rate is well below average. The rate comparison to the right is based on eight thousand gallons of culinary water only.

## **City Meeting Updates for June**

#### Work Session - June 7, 2011

- The Pleasant Grove Strawberry Days royalty invited the Council to Strawberry Days and reviewed some of the events such as the rodeo, parade, and carnival.
- An executive session was held regarding competency of an individual. City Council Meeting June 7, 2011
- A public hearing was held regarding amendments to the Fiscal Year
- 2011 Budget. No comments were received.
   Resolution No. 6-7-2011A was approved regarding a memorandum of understanding for the dissolution of Manila Water Company.
- The review of the current financial statements was deferred to a later meeting.
- Resolution 6-7-2011B was adopted approving amendments to the 2011 Fiscal Year Budget.
- Resolution 6-7-2011C was approved amending the fee schedule. The storm drain and storm drain/flood control fees were increased.
- Approval of the 2012 Fiscal Year Budget was continued.
- Ordinance No. 6-7-2011A was approved making changes to the Youth City Council Advisory Committee.

#### Work Session - June 22, 2011

- The Council discussed the Utility Relocation and Reimbursement Agreement with Provo River Water Users Association. The original cost of \$60,000 has grown to \$217,000 without any explanation from the Association.
- An executive session was held regarding competency of an individual. City Council Meeting June 22, 2011
- A public hearing was held regarding amendments to the Fiscal Year

- 2011 Budget. No comments were received.
- The Utility Relocation and Reimbursement Agreement with the Provo River Water Users Association was tabled until such time as the City has a compelling reason to reconsider the agreed upon or expected financial terms.
- Amendments to the Fiscal Year 2011 Budget were not approved with regards to an outdoor movie screen.
- Resolution No. 6-22-2011A was approved setting the property tax levy for general governmental purposes for the 2011-2012 tax year at .001957 with the General Obligation Bond levy at .001196 for a total levy of .003153. This total rate is lower than the proposed rate from the County of .003195.
- Resolution No. 6-22-2011B was approved regarding the 2011-2012 Fiscal Year Budget.
- An executive session was held regarding competency of an individual.
   Planning Commission Meeting June 30, 2011
- Public hearings were held regarding planned commercial development projects and design guidelines, and animal units (small).
- The Conceptual Site Plan for Holiday Oil was recommended to City Council, with concerns regarding the entrance and exit onto Cedar Hills Drive
- Amendments to the code regarding animal units (small) were recommended to City Council.
- Review of signs and campaign signs was tabled until the next Planning Commission meeting.
- Planned commercial development projects and design guidelines was tabled until there is a future need.

#### **Door-to-Door Sales**

All door-to-door salespeople are required to have a City business license. If someone comes to your door soliciting any type of product or service, please ask them to show their official Cedar Hills identification photo card. If the salesperson does not have one, tell them to go to the City for the license and send them on their way.

Note: Cedar Hills requires all solicitors to submit a background check from their home state.

# Keep the City clear of illegal signs

It's illegal to place signs in the public right-of-way and on traffic signs and power poles, etc. Signs may be placed on private property with permission and a \$1 sign sticker available from the City. Short-term signs, such as yard sale signs, do not require the sticker, but are still subject to placement regulations. Please help keep our city clean and beautiful. View the sign ordinance on the City's Web site: Government>Codes & Ordinances.

### Did you know...?

- If your garbage or recycling toter is cracked or broken, you may call the City office for free repair or replacement.
- The fee for an additional blue recycling toter is only \$2.24 per month. Each additional garbage tote is \$7.13.
- In an effort to keep our streets clean and safe, garbage and recycling toters are not permitted at the curb more than 24 hours before or after the day of pick up.

#### Parking Boats and Trailers

Please remember, public streets are not parking lots for cars, trucks, trailers (for work or play), RV's, boats, campers, basketball standards, etc. According to City ordinances, such items cannot remain on the street for more than 48 hours. Please keep all of the abovementioned items in your yard on hard surfaces. It requires the cooperation of all residents to help keep our streets clean and safe for everyone.

#### Vandalism in Parks and Open Spaces

Unfortunately, every summer the City spends thousands of dollars for repairs on its parks and facilities due to vandalism. We ask the help of everyone to be alert and attentive in watching for this unnecessary destruction and immediately reporting any suspicious activities to the American Fork police, 801-763-3020. The help of our residents in this regard is always appreciated.

#### GreenFiber Recycling

For residents who do not have curbside recycling toters, the City provides a GreenFiber collection dumpster, located behind the City building, FOR PAPER PRODUCTS ONLY, such as catalogs, phone books, office paper, junk mail, and broken-down cardboard boxes. Shredded paper must be bagged. The City receives a small revenue each month based on the weight of the material, and it's a convenient way for residents to recycle. Thanks for your help.

# STORM WATER TIP OF THE MONTH We all live downstream!

During this time of year when we are maintaining our yards, cleaning out garages, and washing cars, remember that all of the water that leaves your property enters the storm drain system and ends up in the local waterways. Here are some important reminders to ensure that our water is protected:

- 1. Apply lawn and garden chemicals sparingly. Excess can get washed out to the gutter and into the storm drain system.
- 2. Make sure that grass clippings and leaves are properly disposed of. These easily clog storm drain systems, preventing them to function properly.
- 3. Landscaping materials that are delivered to your home should never be placed in the street or on the sidewalk. Have dirt, gravel, mulch, etc. delivered onto your property and make sure to sweep up the excess and dispose of it properly.
- 4. Never allow liquids such as motor oil, gasoline, paint, or other harmful items to be washed down the storm drain system. Always use proper disposal practices.

We appreciate the residents who stopped by the Storm Water display at this year's Family Festival. We were able to give away items such as fridge magnets, pens, pencils, frisbees, and beach balls as a way to remind people that "We all live downstream!"

# How do I effectively water on steep slopes and in areas with high clay content soil?

On soils with high clay content, or areas with steep slopes, you may need to cycle. Cycling breaks up the required run time into several short durations, which allow the water to penetrate deeper into the

soil, improving root depth and overall plant health.

To determine if you need to cycle, turn on your system and time how long it takes for water to start running off. This is the maximum amount of time you should water in one cycle. Divide the recom-

mended minutes by this to give you the number of cycles to run. For example, if water begins to run off after seven minutes, divide the suggested number of minutes (21) by seven. This gives three cycles, which can be scheduled as shown.

# "Ouch! Where's my ring?"

Recently, some well-meaning residents removed the protective rings around the base of many trees along Cedar Hills Drive and in Sunset Park along the trail. These rings were installed to protect the trees when mowing and trimming is done. The City has a licensed land-scape contractor, and he is the only one authorized to remove or install these protective rings. Removal by any other party equates to theft, as these items must be replaced. If you see something that concerns you, please contact the City and allow the appropriate individuals to review and correct the item.



### Increased services necessitate increased fees

Due to additional EPA regulations imposed on cities, storm drain costs have risen dramatically over the past year. The City's monthly residential storm drain fee was increased \$1 per month to help the City fulfill these requirements.

Additionally, due to the staffing of the Cedar Hills Public Safety Building with full-time firemen and paramedics, the City's portion of the Lone Peak Public Safety District budget has increased significantly, requiring a raise in the residential paramedic fee to \$5.95 per month.
