7. Review/Recommendation on Amendments to the City Code, Title 10, Chapter 5, Supplementary Development Standards, Regarding Signs and Campaign Signs (6:12 p.m.)

Staff Presentation:

Eric Johnson reported that the City received a letter from an attorney questioning the City's sign ordinance. This attorney has filed suit against a variety of cities around the state over the last six months. The City Council suspended enforcement of its sign ordinance to avoid suit and to review the sign ordinance. Eric Johnson has done extensive research regarding the sign ordinance and has learned some wonderful or disturbing things. More than 95% of all reported challenges to municipal sign ordinances are successful. You can't regulate a sign based on what it says. The courts regulate sign ordinances just as they regulate speech. The proposed ordinance makes three distinctions, i.e. commercial and residential zoning, commercial speech and noncommercial speech, and temporary signs and permanent signs. Signs can be regulated by time, place, and manner. There is a bill before the Legislature regarding signs that in residential zones a city can't require permits or a temporary sign. It states a temporary sign can be up for at least 120 days and can be at least a two-sided, 30-square-foot sign. Some court cases have allowed more restrictive signs than the proposed bill. The City should wait to see the outcome of this bill before passing a new sign ordinance.

MOTION: C. Dodge - To table the sign ordinance until the legislature has reacted. Seconded by Steele.

Further Discussion:

Eric Johnson stated that he will recommend that the City have a very light hand in regard to temporary signs in residential areas. He will likely recommend that temporary signs be allowed without a permit but with regulations regarding the setback from the road and square footage. After six months the City can approach the homeowner to find out if the sign has been abandoned. If there is no response, the City can deem the sign abandoned.

Staff Presentation:
